"BETWEEN THE BUMPERS" ... By Ed



Jim Peek's 1968 Oldsmobile 442

Many times, we decide on actions that we greatly regret and unfortunately never have a chance to recreate again. This is a story of lost, found and my redemption.

It all started in the fall of 1967 when my dad went to the Seattle Auto show. He came home and said he ordered a brand-new red Oldsmobile 442 hard top on the spot. He loved the lines and cared less about the performance. I was almost 15 years old and it seemed like it took forever until it finally arrived in February of 1968 at a dealer in Arlington, Washington. When I was 15 ½, I got my drivers learners permit and it was the car I used to take on my driving test on January 6, 1970... my birthday.

I was a very lucky kid since it was my dad's habit to let you have the car, he was driving at the time you turned 16 and he would buy another new car. He did this for my two older brothers, and he did the same for me. I drove the 442 through high school and acquired a VW bug to drive in college. For the most part, the 442 just sat in my dad's driveway while still in his name until 1988 when he made it official and transferred the title to me. The paint was in poor condition with rust in all the typical places.

My first redemption of the car took nearly 10 years and about \$42,000. Every part of the car was restored... I loved the process of buying parts and adding W-30 parts like the air induction system, factory tach, Cragar wheels, stripes, W-32 cam and headers ... just like I'd dreamed about doing in high school.

I enjoyed going to car shows including the 2005 Oldsmobile Club of America Pacific Northwest National meet held in Seattle and was given a "Best in Class" wood plaque which I treasure. I continued to show the car until 2009 when I got a wild idea to sell the 442 and buy a Toyota Tacoma, a small travel trailer and a Kubota tractor for up at the cabin with the car proceeds.

After the car sold, I knew I had made a big mistake. The 442 went to a new owner in Idaho who was blind. He had owned one just like it before losing his sight and remembered how much he loved the shape of the car. He would put on thick cotton gloves to feel the car and run his hands over the curves. His wife would start the car and back it out of the garage so he could listen to the engine. I told them if they ever wanted to sell the car, "please call me". After a few years I wanted to buy it back, but they moved with no forwarding address and the phone was disconnected. I had no contact information about the car for 10 years. I found myself watching car auctions expecting to see it on the block. Other times I went to the dark side thinking maybe the car was wrecked and in a scrap yard somewhere.

Out of the blue in December 2019 I received a general Christmas updated letter from the now widowed first buyer. There was no phone number but the address of her nursing home in Idaho on the envelope. I wrote her a letter and 4 weeks later she answered that the car had been sold to a car collector in Idaho and she gave me the phone number and contact info. Well, within 30 minutes of acquiring the owners contact information we had negotiated a buy back price.

During our conversation the owner informed me that the car was part of a 26-car collection of mostly Mopars and I was very lucky since he was preparing the car to be sold at the March Mecum Auction in Arizona. He also advised that he had put only 100 miles on the car since I sold it in 2009! I lucked out again by finding an enclosed truck available in Idaho in the winter and my car was delivered near my home within 5 days after the purchase where it is going to live forever in my life. We are reunited once again! It is as if I had put the car into heated storage and it was frozen in time for 11 years.


